Because of expense uncertainties we cannot list operating expenses at this time, but we will have an annual financial report on the operation and construction of the pool and tennis courts at the end of the year.

The grading contract for the swimming pool has been completed and payment has been made. The swimming pool contractor (JoPa) still needs to have the subcontractor complete some repair work on the concrete apron. The final 10% payment due JoPa will be made when that is accomplished.

There has been some concern about the membership capacity, and the Board is considering various alternatives of capacity levels.

COMMITTEE REPORTS

CONSTRUCTION COMMITTEE

At the September 24th Board of Directors meeting the Const. Comm. recommended that Calico Courts be selected to build our first two tennis courts. Calico Courts could construct a set of double courts this fall. All construction will be completed except for the final top Laykold surface, which will be put down next spring. The top surface cannot be laid this fall due to possible inclement weather. The courts will be playable this fall be painting lines of the asphalt. This low bid is approx. \$3000 over the budgeted figure of \$16,000 due to increased labor and material costs. The final bid has been submitted and

approved by the Board of Directors at this time. Construction is expected to begin by the first of next week subject to the actual letting of the contract.

MEMBERSHIP COMMITTEE

The membership committee is pleased to announce that our total membership is now 116. We have gained nine new SHRC members since the pool opening. Of these, two are replacement members and four are trial members. We hope that the trial members enjoyed the pool this summer and will become full members by October 15th.

The membership committee's efforts are now focused on a membership campaign. A brochure has been printed, plans have been organized and we will be recruiting your help in the coming weeks. If many can pitch in and do a small part our job will be more successful.

The swim season is over for this year. The task before our committee is to evaluate our performance in all aspects this past season, towards improving it for next year. In early 1979 we will go over in detail each report's recommendations.

Pool Closing – We have pretty well wrapped up closing the pool for this year. We have secured our equipment, drained the water pipes and lowered the pool level below the skimmers. The water has been superchlorinated to prevent algae buildup. The cost of this closing is minimal.

Lawn furniture – All members' furniture left at the pool has been secured in the supply room. We will be happy to store it for you, but we cannot be liable for loss or damage. If you would like to pick your furniture up, please contact Bob Burton 467-3024.

Tennis Courts – While the final decision has not been reached, our intent is to control access to the courts by means of serial numbered nonreproducible keys. Keys will be issued to those members requesting them and refundable deposits will be required.
